Program Description

The PGY2 Informatics Residency is designed to introduce and prepare the resident for a career in Health System Pharmacy Informatics. The longitudinal experiences in clinical informatics, pharmacy automation management, and data analytics will provide solid experiences in Pharmacy Informatics. The resident will be immersed in the Pharmacy Medication Use Systems and Technology (MUST) team, while rotating through various experiences and managing initiatives over the course of the year. In addition to rotations, the resident will be exposed to clinical, operational, safety, financial, and regulatory projects to supplement education, and will learn how to use a system approach to solve issues and requests. The resident will collaborate with other health system disciplines to optimize and improve medication use technologies. The resident will select a major project which will be presented at the Western States Conference.

Residency Requirements

- The applicant must be a graduate of an accredited School of Pharmacy with a Doctor of Pharmacy degree (or in process of completing).
- The applicant must have completed a PGY1 program or have equivalent health system pharmacy experience.
- Candidates must be eligible for licensure in California and resident is expected to be licensed within 3 months of the start of the program.
- Staffing requirement is every 3rd weekend.

Benefits

- Benefits include 26 days of Vacation and Holiday Time (VHT), 10 of which are used for educational days, as well as medical and dental insurance.
